#### BREATH PRAYER FOR PEACE

Scripture Reading on Peace: Philippians 4:1-9

Breathe In: You might begin by exhaling *peace's* opposite which is discord, war, and distress. Imagine *peace* filling and spreading through your body with each inhale and letting go of any discord, warring, and distress with each exhale.

Soon you'll not only be able to picture yourself breathing in *peace* but you will have such an abundance of *peace* it will overflow and you'll begin breathing out *peace* into the world. Practice consciously breathing *peace* in and out as long as desired.

**Breathe Out:** How can you breathe out *peace* everywhere you go? Remember Hildegard of Bingen's words and allow yourself to be "a feather on the breath of God."

November 5, 2017, was the date of the annual ham dinner sponsored by the Presbyterian Church of Grandin. We served dinner at the hall until 1:00 p.m., then ate together and cleaned up. It was mid-afternoon when I got home, changed clothes and sat down to read the paper. I

turned on the TV to news of the mass shooting at First Baptist Church of Sutherland Springs, TX.

As a graduate of Austin Presbyterian Theological Seminary, I am familiar with that area of Central Texas. I did not recognize the name of Sutherland Springs, so I looked for it on a map. It is less than 50 miles from one of my favorite preaching points from seminary days, Cheapside, TX. The church buildings even bear a resemblance to one another. The Sutherland Springs church also bore a resemblance to several of our churches here in the Northern Plains.

In February, 2016, Sanford Hospital in Fargo and local law enforcement had planned a presentation for local congregations on what to do if there was a threat to your church campus. It was postponed for several months because Officer Jason Moszer was shot and killed the night before it was to occur. Local law enforcement had other things to deal with. We met together for lunch and discussion anyway, and received some statistics that were frightening. Congregations like Sutherland Springs and many of our congregations are more likely to be targeted because they are rural and law enforcement will not be able to respond quickly, offering a chance for the perpetrator to escape. There were also statistics about the likelihood of an event based on denomination. Presbyterians are near the bottom of the list of churches that are likely to be targeted, as are the denominations we are most likely to federate with in this area, Lutherans and Methodists.

The following Sunday, in addition to praying for the people of Sutherland Springs, we had a conversation in my congregations about what to do if such a thing were to happen here. Congregations need to have an emergency plan just like families need to have an emergency plan in case of fire or storm at home. It is unfortunate that most of us have neither.

Next time you are in your sanctuary, look around with new eyes. Locate all the exits, even those you have never used; those that are never used by anyone. Look at the church furnishings; where could you take cover if you cannot get out? What could you throw at the perpetrator to distract him and allow others to escape? How quickly can you dial 911 on your cell phone?

God has promised to be our refuge and strength, but things still happen in this world due to our sinful nature and misuse of the free will granted to us by God. It is especially unfortunate that this is our topic in the month when we are again preparing ourselves for the coming of the Prince of Peace. What can we do, not just now, but in the future as individuals, congregations and as a Presbytery, to help bring peace to our world?

Have a blessed and reflective Advent, and a very merry Christmas.

## RESOURCES TO PROTECT YOUR HOUSE OF WORSHIP

Across the United States, Americans congregate in faith-based venues to worship, learn, play, and bond as a community. However, public gatherings are vulnerable, and adversaries may perceive houses of worship as attractive targets where they can inflict mass casualties, cause substantial psychological impacts, and draw extensive media coverage.

The Department of Homeland Security (DHS) offers numerous resources to assist faith-based and community organizations with their efforts to prepare for all types of hazards, whether natural or man-made. Technical assistance is provided through presentations, workshops, training, webinars, tabletop exercises, and training.

In coordination with interagency partners, the DHS Center for Faith-based and Neighborhood Partnerships and Federal Emergency Management Agency (FEMA) established a website for faith-based organizations that serves as a "one-stop shop" for information on available Federal tools, resources, and assistance: <a href="www.fema.gov/protecting-houses-worship">www.fema.gov/protecting-houses-worship</a>. Additionally, DHS's National Protection and Programs Directorate (NPPD) offers a wide range of security and resilience tools, training, and resources. Through its <a href="Hometown Security">Hometown Security</a> (<a href="https://www.dhs.gov/hometown-security">https://www.dhs.gov/hometown-security</a>) initiative, these resources are made available to communities, including faith-based organizations. Many of these resources were created in collaboration with private sector partners to ensure they are useful and reflect the evolving security landscape. The list of resources in the link will help the private sector with their security planning, and many of these practices can also be used more broadly in local venues visited by large numbers of people, such as faith-based organizations.

As part of the DHS Hometown Security initiative (<a href="www.dhs.gov/hometown-security">www.dhs.gov/hometown-security</a>), DHS asks communities to Connect, Plan, Train, and Report. Applying these four steps to prepare for an incident or attack can help . . . to plan for their role in the safety and security of their businesses and communities.

## NUMBER OF COMMISSIONERS CHANGE FOR PRESBYTERY MEETINGS

"Things they are a changin" at Presbytery! At the Presbytery meeting in October, commissioners voted on changes to the bylaws. Updating the bylaws became necessary to complement the structural changes of committees to pods. All the bylaws came up for review, including **B-2.0300 Ruling Elder Commissioners.** From now on, churches with a membership of 100-300 are invited to send **two** ruling elder commissioners to presbytery. This includes our churches in the following communities: Hallock, Grand Forks, Casselton, Rolla/St. John, Moorhead, Mandan, East Grand Forks, West Fargo and Jamestown. Churches with a membership of over 300 may now bring **three** 

ruling elders. This includes Bismarck and Fargo. Congregations with fewer than 100 members will continue to bring one ruling elder commissioner. We hope this will increase our participation at Presbytery and share more equitably our work together. # IT'S ALL MISSION, NOT JUST THE MISSION POD

When discussing church business at the Leadership Pod, I was reminded that all of church business is "mission"; not just what occurs within the Mission Pod. What does this mean? That everything we do within our individual congregations or within the Presbytery structure should reflect or be based on the faithful witness to the Good News of Jesus Christ. As we develop the Mission Pod activities, I hope and pray that we keep this in mind.

The Mission Pod is charged with overseeing the missions of the Presbytery. They are the 1) University of Jamestown; 2) Clearwater Forest; 3) Chogoria Ministry; 4) Bdecan Mission and Food Pantry; 5) Youth Connection; 6) Earth Care; and 7) 1001 Worshipping Communities. Each mission team has at least a member from three different congregations within the Presbytery and meets on a semi-annual basis and submits reports to the Presbytery regarding ongoing activities. The Mission Pod also includes representatives from Presbyterian Women and Self-Development of People Committee.

Our goals for the coming year are to educate congregations on the missions of Presbytery, to enhance fund-raising by the mission teams, and to encourage the use of designated mission funds for the faithful witness to Jesus Christ. We hope to provide answers to questions that church members might have about where the mission funds go. This might be in the form of a weekly or monthly mission statement about one of the missions; "talking points" for sessions to use as they determine their unified mission giving; how new missions can be formed; and stewardship of our talents and gifts.

Let me give you an example. University of Jamestown has a covenant relationship with the Presbytery and receives funding through the Mission Pod. Where does the money go? The University has called a full-time chaplain and the Mission Pod has asked that the funding go to support the campus ministry program. We are hoping to hear more about the campus ministry program in the future and know that this will support the overall mission of Presbytery of the Northern Plains.

The session at Glencoe Sloan Memorial recently met and I gave a presentation on what happens to the dollars that are sent to the Presbytery through the unified mission giving. The discussion that followed was heart-warming and thoughtful and led to the determination of Glencoe's pledge. Is this the discussion that all churches would like to have? Can the Mission Pod provide information to individual sessions as they meet to determine their budgets for the coming year? Or in years to come? What information would individual churches like to have? If all our work within the Presbytery is mission-based, I pray the Mission Pod will be stewards of your giving.
