CALL FOR THE APRIL PRESBYTERY MEETING

The one-hundred-fourteenth Stated Meeting of the Presbytery of the Northern Plains will be held at the First Presbyterian of Oakes, North Dakota, on Friday and Saturday, April 1 and 2, 2016. Registration will begin at 11:00 a.m. with the meeting convening at 1:00 p.m.

The meeting will open with worship, including the celebration of Holy Communion. The church members in Oakes are looking forward to hosting us so start making your plans to attend. As always, we ask that you bring your stories about Good News in your congregation and community to share with others.

RECOMMENDATIONS REQUIRING PRESBYTERY ACTION:

Treasurer's Report

Year 2015 in Review

I would like to express thanks for your congregation and session's ongoing support of the Presbytery of the Northern Plains. We appreciate the financial contributions that have been made and seek to honor the trust bestowed in us by serving you in return.

Budget wise there was a projected \$50,309.00 deficit for the Fiscal Year 2015. However, the year-end budget shows a surplus of \$1,850.00. There was a net increase of \$17,085.00, which came mainly from Donor Restricted Giving to the Presbytery.

Further in this report you will find the 2015 Mission Giving Report. Please review it and make sure that our records match yours. During the last quarter of 2015, the Budget and Finance Committee started to explore a new software accounting system for Presbytery. As of January 1, 2016, the Presbytery has starting using the new system, which is a work in progress. The 2016 financial information, period ending February 29, 2016, is from this new system. A big thanks to the Finance Committee; Sheri Stern, Ellen Misialek, Dan Wolpert, and Marilyn Ogden for their assistance in this project. A special thank you to Laurie Elhard for the extra effort and time she spent installing and setting up the software.

Per capita is an important part of the life-blood income that supports the budget of Presbytery of the Northern Plains. 2016 Per Capita as approved at the October Presbytery Meeting is:

Grant Information

The Presbytery of the Northern Plains has the following grant opportunities available. It is the hope that these funds will allow the opportunity to assist you in completing a project or starting a new ministry. Peacemaking Grant

The Peacemaking Offering supports the peacemaking efforts of the church at every governing body level and provides an opportunity to witness to God's gift of peace in the world. Gifts given to the Peacemaking Offering through a congregation are divided in the following manner - twenty-five percent retained by congregations for support of their own peacemaking ministry; 25 percent used to support presbytery and synod peacemaking efforts; and 50 percent forwarded to the Presbyterian Peacemaking Program of the General Assembly Council so that it can continue to provide assistance and resources for congregations and other bodies of the PC(USA).

Balance: \$ 2,167.51

Balance: \$ 1.452.21

The emphasis is broad: a congregation, elder or pastor can apply for funds for anything which 'makes for peace' (mission trips, racism training, new ecumenical work). An <u>Application for Grants</u> form should be used and sent to the Presbytery of the Northern Plains Council.

Clergy Renewal Grant

The Clergy Renewal Fund was created by the Bicentennial Campaign in the early 1990s. 90% of the interest from the endowment is returned to the Presbytery quarterly and lodged in the designated reserve account ("Clergy Renewal Interest") 10% of the interest is reinvested for growth of the principal. The Clergy Renewal is invested. The purpose of the fund, defined by the Presbytery in 1993, is:

- a) Retreats for clergy (this includes CRE's) and spouses
- b) clergy convocations
- c) clergy scholarships for continuing education and sabbaticals
- d) other emerging needs for clergy renewal

The Committee on Ministry has the responsibility for developing processes and applications for use of the funds, and for granting approval for requests made to the fund. The Committee on Ministry shall report to the Presbytery at least annually on the dispersal of funds. An <u>Application for Grants</u> form should be used and sent to the Presbytery of the Northern Plains Committee on Ministry.

Pentecost Grant Balance: \$ 567.68

The Pentecost Offering enables the PC(USA) to encourage, develop and support its young people, as well as provide assistance to at-risk children. In addition, a large portion of this offering can be kept by individual congregations for use in their own communities.

The Pentecost Offering is traditionally received on the day of Pentecost. However, you can help sustain the important PC(USA) ministries and programs that are supported by the Pentecost Offering by making an online gift at any time throughout the year.

These are monies received from the Pentecost offering and retained by the Presbytery. An <u>Application for Grants</u> form should be used and sent to the Presbytery of the Northern Plains Council.

New Church Development Grant

These are funds retained by the Presbytery for New Church Development. A 'new church development' means reaching new population with the gospel of Jesus Christ.

This fund represented monies received from the sale of the property in South Fargo, and designated by the Presbytery for New Church Development. This fund has been designated for the use to start a new worshipping community in Dickinson, ND.

No new grant application are being accepted at this time

Congregational Development Grant

The Congregational Development Fund was created by the Bicentennial Campaign in the early 1990s to bring seminary interns to plains churches. No funds are returned to the Presbytery automatically, but the Presbytery may request a portion of the funds annually.

The Committee on Preparation for Ministry administers the fund, and needs approval of the Presbytery to request more than 5.5% annually. An <u>Application for Grants</u> form should be used and sent to the Presbytery of the Northern Plains Committee on Preparation for Ministry.

Small Church Ministries Support

These funds are to go toward to use of helping support small church ministries within the Presbytery of the Northern Plains. An <u>Application for Grants</u> form should be used and sent to the Presbytery of the Northern Plains Council.

New Ministry Support / Misc Grants

Typically, \$5,000 is set aside to fund grants to congregations to help facilitate new ministries ideas or to aid pastoral leaders within the Presbytery of the Northern Plains. The grant application process is open ended with no deadlines set, however once the funds are depleted, no more grants will be available until the funds are replenished.

In the past no funds were available for church renovation projects, however in January 2013, Council established guidelines regarding church improvement fund requests. It reads, "Presbytery Council encourages churches to apply for funds to help improve their buildings, if they have need for such funds. Application should be made through the ministry grant request process, using that application form. Churches should NOT apply for more than 50% of the total cost of the project. Projects that make churches more accessible will be given priority. Funds will be awarded as budget constraints allow."

An <u>Application for Grants</u> form should be used and sent to the Presbytery of the Northern Plains Council.

Seminary Scholarship

Income from offerings taken at ordinations and installations (see P-6.01012c) as well as income from the Julia Euland Fund are deposited into the Seminary Scholarship Reserve Account, to be disbursed by the Committee on Preparation for Ministry for use for scholarships for seminarians from the Presbytery of the Northern Plains. No application needed as long as individuals are under the care of the Presbytery of the Northern Plains.

1. **Motion:** The bylaws be amended to reflect that the Ministry Teams would be represented on Presbytery Council by two people with an alternate designated by the Ministry Teams and that the terms of these representatives would for one-year with an option to renew on a yearly basis. **Approved at October 23, 2015, Presbytery meeting.**

The following are the sections which need to be amended to put into effect the bylaw changes approved at the October 23, 2015, Presbytery meeting. The actual language requires additional Presbytery approval.

B-5.0200, MEMBERSHIP

B-5.0201, Voting Members

Voting Members shall be: Chair of Council, who shall be elected by Presbytery for a term of two years and shall be eligible to serve a second two-year term, but shall not serve more than four consecutive years; the immediate past Moderator of the Presbytery; the present Moderator of the Presbytery (who shall be vice-chairperson of the Council); the Vice-Moderator of Presbytery; the chairpersons of the Standing Committees of Presbytery (4): Committee on Representation, Committee on Ministry, Committee on Preparation for Ministry, and Nominating Committee; chairperson of the Budget and Finance Committee of Council; chairperson of the Personnel Committee of Council; a representative designated by and from the Presbyterian Women of the Presbytery and elected by Presbytery; the Presbytery's commissioners to Synod and General Assembly; the representatives designated from each the Ministry Teams as provided in B-6.0500. (February 5-6, 2010; March 9, 2013, October 2014, April 2016)

B-6.0500 MINISTRY TEAMS

To facilitate and enhance the work of the Presbytery, persons may gather themselves around an issue or area of ministry for which they have a passion and concern. Normally, such teams should consist of a minimum of three people from three different congregations in the presbytery and should apply to the Council for recognition. In doing so, the new team should offer a brief description of its purpose, its membership, and what, if anything, it is expecting from the Presbytery. Teams will abide by the policy for Committee and Team Chairs in establishing leadership. Once recognized, the ministry team shall submit a written report of its activities at least semi-annually to the Council and annually to the Presbytery. If a team is receiving funds from Presbytery, it must meet, either in person or electronically, at least twice annually. These meetings must have minutes which indicate a quorum was present and voted on the use of fund. Each Ministry Team shall designate voting representation to Council with no person representing that Ministry Team to serve more than six consecutive years. The Ministry Teams will be represented on Council by two people with voice and vote and an alternate designated by the Teams. The terms of these representatives shall be one year with an option to renew on an annual basis. The Council shall submit an annual report to Presbytery, indicating which ministry teams are actively complying with the above guidelines.



Presbytery of the Northern Plains CHILDREN AND YOUTH PROTECTION POLICY

The Youth Connection Team committee recommends that churches develop guidelines for care and supervision of children and youth involved in the programs sponsored by their church. We recognize that different church and programs have various needs that should be taken into consideration when establishing guidelines. The following are suggested areas for consideration.

I. Adult-child/youth ratio

Appropriate adult-child/youth ratio should be observed always, with two adults present at all times:

To Maintain the ratios of one adult to four kids for Infants and one to eight for pre-school and older; additional adults to the first two will be required as follows:

- Infant/Crib Room Ratio should be one adult for every additional four children
- Preschool & older (including middle school and senior high youth activities)
 - One adult for every additional eight children.

When possible, especially with older elementary youth and teenagers, a male and female adult should be present. There are state guidelines with respect to adult/child ration that can be consulted.

II. Check-In/Check-Out System

Age appropriate check-in/check-out systems should be established, e.g., a sign-in sheet for infants/toddlers indicating what time the child was dropped off, when they are to be picked up, and who will be picking up the child.

Elementary age youth and older will need to sign-in and out of an event. With high school youth who drive, it should be understood, with parental approval, who may ride with whom, to and from activities.

III. A Touching and Toileting Policy

Nursery and Toddlers

- *Hugging, holding, back rubbing and patting are all acceptable and important ways of communication love and care for a child.
- *Genital areas should never be touched except during diaper changing or toileting as is appropriate.
- *Children should not be tossed in the air, swung by their arms or legs, or tickled.
- *Children have the right to refuse touch, except for safety or cleansing.
- *Touching should be something the child wants and should be done respectfully.

Ages Four, Five, and Kindergartners

- *Children should only be touched from the shoulders up. Touching the genital or buttock areas is never appropriate. Hugging is appropriate only in supporting a child's need but never if a child declines the desire for such comfort.
- *A teacher or helper should avoid being alone in a room with a child or a group of children.
- *An adult must accompany children to the lavatory. The adult should wait outside until the children are finished. The door to the lavatories may be propped open so that the adult can hear and see what is going on without actually being inside. An adult should never be alone in a lavatory stall with a child.
- *If a child requests help with buttoning or zipping after toileting, the adult should comply in the presence of another adult.
- *When possible an adult of the same gender should assist the child.

1st Grade and Older

*Children should only be touched from the shoulders up. Touching the genital or buttock area is never appropriate. Hugging is appropriate only when requested by the child.

*A teacher should avoid being alone in a room or a lavatory with one child.

IV. Discipline

Churches rely on volunteers to implement programs. One of the challenges is to communicate and establish positive behavior. Establishing a behavior covenant that all children/youth and adults agree to is important. E.g., *Children and staff will covenant together to show respect in three special areas.

1.) We will be respectful of God by:

Discovering who God is and what God has done for us.

Loving and serving God.

Paying attention as we worship and learn about God.

Doing our best not to disturb others in their worship of God.

2.) We will be respectful of the church building by:

Being careful not to run, push, or damage property.

Staying out of locked or closed areas of the building.

Remembering that the church belongs to Christ, not to us.

3.) We will be respectful of all God's people by:

Learning to love and accept ourselves and others as Christ loves and accepts us.

Never hit, kick, hurt or make fun of others.

Obeying those who are teaching and leading us.

Showing care and compassion to others, remembering that each of us is "child of God" and should be treated as such.

There should also be an established set of consequences for those who are unable to live up to the covenant such as:

A child will be given a warning in a manner that should not cause embarrassment. If the child's behavior repeatedly falls short of the expectations of this covenant, they will be excused from the class or activity, at first for a short "time out". If the child is not able to control his/her behavior after the time out, the child may be sent for a time out with one of the staff members, away from the class or activity. If the child is habitually disruptive, parents will be consulted and a conference will be scheduled so that no misunderstanding will occur. The parent may be asked to accompany the child to the program for a given period of time, or the child may be excused from the program. It goes without saying; the door will always be open for the child's return when he/she is willing to live by the terms of the covenant.

V. Youth Trips

A "Covenant of Understanding" should be developed and signed by both the youth and parents. Things included in the Covenant should be expected behavior such as:

- *No smoking, drinking of alcoholic beverages, or use of illegal drugs.
- *Appropriate public displays of affection should be observed; sexual activities not appropriate by definition are that which go beyond propriety.
- *When the activity is overnight and there are separate sleeping areas for each gender, the space should be respected by the opposite gender. If ratio cannot be met, the door must stay open.
- *An understanding of the consequences of not living according to the Covenant such as being sent home at the expense of the parents.

Adult sponsors should remember that they are responsible for the youth and should act accordingly. It is important to relate and participate with the youth in activities but the adults should not encourage activities or behavior that would lead to the breaking of the Covenant. At the heart of youth ministry is relationships.

The relationships between the adults and youth are very important; however adults, need to be sure that they are not alone with a youth in a private area. If there is a reason for the adult to have a one-on-one conversation with a youth, it should be held in a public place.

When the youth activity includes the youth being transported in private cars, adult advisors should be the only drivers. Youth should never be allowed to be put in a position of liability.

VI. Reporting of Incidents

A system for reporting incidents should be established. Volunteers are trusted to make decisions to deal with situations at the time they occur. In order to protect and support the volunteers and children/youth, church incidents involving confidentiality need to be clear in terms of to whom and how an incident is reported. Incidents should be reported to the Pastor or lead person of the church or facility (camp, recreation center, etc.) if incident occurred in their building. Social networking through the use of Internet-based and electronic social media tools, such as: Facebook, Twitter, blogging and other online social media vehicles are part of everyday life. Using social media for yourself is different than using it on behalf of [CHURCH NAME], so it is important to be prudent: everything that is posted online, regardless of privacy settings, etc., is permanent, pervasive and public. This document is intended to provide [CHURCH NAME] staff with guidelines to eliminate any confusion concerning the use of social media.

Best practices to use social media successfully:

- 1. **Be responsive.** Set up notifications to be informed when someone posts to your page, and be prepared to respond quickly—within the hour if possible and certainly the same day—even during evenings or weekends. Get someone to cover for you if you expect to be unavailable. If you don't know the answer, it is better to say, "We will find out and get back to you" than to not answer at all.
- 2. When controversial actions, events, or decisions are anticipated. Discuss with leadership what strategy and steps will be followed when someone posts or tweets about the issue in a critical way. Have church leadership decide who will respond to comments and when approval may be required.
- 3. **Dealing with negative comments.** While obvious spam posts can be deleted, comments should be allowed on blogs, Facebook pages, and other places. Do not automatically delete negative posts. Instead, respond kindly with accurate information. If the person wants to engage in a lengthy battle or appears to be promoting an agenda, just stop answering.
- 4. **Be responsible.** The fast pace and transparency of social media means we will get things wrong sometimes. That is okay if you handle it gracefully; starting with acknowledging your error. If you make a mistake, admit it. Be upfront and be quick with your correction. What you write is ultimately your responsibility. Participation in social media on behalf of [CHURCH NAME] is not a right but a ministry, so please treat it seriously and with respect.
- 5. **Questions.** If the poster has specific questions about programs or policies, direct them to an email address for the person who can answer those questions, or to the private message function on your organization's Facebook page. Also, notify the person who you have identified as a point person for questions that this person will be contacting them and ask them to respond as quickly as they can to avoid any further public postings. Criticisms or questions are best answered in private, and every care should be taken to avoid a protracted comment battle.
- 6. **Page moderation.** On Facebook, in the administration portal, block users from posting comments with obscenities. You will find it under Settings and then Page Moderations.
- 7. **Display guidelines for comments on your page.** A good guideline for Facebook, YouTube and other social menu venues is to post something similar to this disclaimer in the bio or "about us" section:

- a. We welcome your thoughts in this space. We ask that you are respectful in what you post and in your comments about other members of the community here. If you'd like to know more about us, visit our web site at [WEBSITE HERE].
- 8. **Use proper hashtags.** Never use a hashtag without first being sure you know the origins and proper use. Search online through www.hashtagify.me or other means to see if and how it's already being used on social media.
- 9. **Post context for links.** If you want to share a news story on Twitter, Facebook, etc., add a sentence or two that tells what the story is about, so the potential reader will know what they're going to visit when they click on the link. Avoid lengthy posts. For example, a good length for a Facebook post is 2-3 sentences.
- 10. **Avoid acronyms.** They are difficult for readers to figure out.
- 11. **Do not use first-person language on a page you manage.** Use "we" to refer to a group of people or the church by name, but do not use "I." There is no entity represented by a single person.
- 12. **Update your status regularly and strategically.** Social media channels should be updated frequently. You can use a free timing tool like hootsuite.com to schedule posts in advance to various social media channels for days you won't be working. If you use a scheduling tool, be aware of events in the larger world. If a major national news events has just occurred, posting about something completely unrelated is usually seen as a blunder.
- 13. **Use analytics to plan.** Based on your social media goals, track and measure people reached and/or impressions and engagement rate. These numbers will help gauge success and improve what types of content to post in the future.

Best practices for using social media to promote events:

- 1. Do not create separate social media pages or accounts just for the event itself.
- 2. Pre-event planning:
 - a. Meet with the social media manager and/or church leadership 6 months prior to the event and again one month before the event starts to discuss goals and messaging.
 - b. Develop a web page early with information about the event. This is the place to refer people from Twitter, Facebook, etc.
 - c. Choose a hashtag for the event that is short and unique, and use it on all posts in all social media. Hashtags make social media searchable. Search online through hashtagify.me to be sure your hashtag is not being used by anyone else. Adding a year to your hashtag is one way to help make it specific. Avoid generic hashtags (#presbyterian, #church) in favor of tags like #BigTent14, #GA221, #PYT13, etc.
 - d. Be responsive. As the event gets closer, be ready with answers that people ask about the event.
 - e. Plan social media posts around early-bird dates, registration deadlines, and start dates and times.
 - f. Tag other churches or organizations that are involved with your event (when possible), so they can share your content and help you spread the word.

3. During the event:

- a. Don't "over-post" on Facebook. Group photos in albums, so you don't flood the Facebook feed for people who may not be interested.
- b. Post as soon as possible after a session ends. Very current content keeps followers engaged. Be sure to proofread carefully.
- c. Use the names of people in photos as much as you can. Taking a photo of the badge of a person at a conference separate from their portrait is a good trick that helps you keep track of those involved. You may need their name later.
- d. We will not tag photos, however, you may tag yourself in photos that are posted on social networks.
- e. Live-tweet events, but not excessively. Pick up a few key points from each session and hashtag them with the event hashtag.

4. After the event:

a. Continue to post a few items for a short time to wrap up any loose ends.

Recommendations for personal social media usage. As [CHURCH NAME] staff, you are likely viewed by friends, family, and other followers as a representative of [CHURCH NAME].

- Be transparent and honest about your identity, and you may want to say something like, "The views I express are not necessarily those of the [CHURCH NAME]."
- Be accurate. Before posting, take a moment to Google a news story to be sure you have facts correct. Rely on mainstream, reputable news sources.
- Be respectful. Long, drawn-out arguments on social media consume energy and cause emotions to flame. It is easy to become angry and post insults. This damages your reputation and the reputation of the [CHURCH NAME], and is best avoided.
- Maintain confidentiality. Do not post confidential or inside information about the community members of [CHURCH NAME] or staff. In general, don't post anything about your work that you would not present at a conference.
- Posting events, photos, videos. You may post about official [CHURCH NAME] events on your personal page, but the best practice for page administrators is to post on the organization's page first. You may share to your own personal page or create an entirely new post, but you should tag your organization's page when doing so. This will encourage more people to like and interact with your page.
- Be aware of liability. You can be held legally liable for what you post on your personal site and on the sites of others. Individual bloggers have been held liable for commentary deemed to be copyrighted, defamatory, libelous or obscene (as defined by the courts).
- Protect your identity. Don't provide personal information (home address, telephone number, or email address). It is a good practice to create a separate, non-work email address that is used only with your social media site.

Empowering the Presbyterian Mission Agency Offices to Speak To Injustices Related to Fossil Fuel Extraction, Transport and Storage

Recommendation

The Presbytery of the Northern Plains overtures the 222nd General Assembly (2016) to:

Empower The Office of Public Witness (OPW) in Washington, D.C., and the Presbyterian Ministry to the United Nations to witness against environmental degradation and to affirm public policy that supports good stewardship of natural resources. With firm biblical foundation and the policies of twenty General Assemblies to build upon, they may give voice to threats to air and water quality; threats from fracking; threats from crude oil transport and storage; and indeed all modes of fossil fuel extraction; threats from methane that results from industrial processes. This empowers both offices to speak for the church to uphold the integrity of creation and speak against injustices.

Rationale

Our charge is clear:

Hosea declared in times of no faithfulness, "...the land mourns, and all who live in it languish; together with the wild animals and the birds of the air, even the fish of the sea are perishing." (Hosea 4:1,3)

Jesus heard the lawyer reply, "You shall love the Lord your God with all your heart, and with all your soul, and with all your strength, and with all your mind; and your neighbor as yourself" and told him "...do this, and you will live." (Luke 10: 27-28)

Calvin lifted up the "lively image of his (God's) wisdom, power, and goodness in the creation of the world, and in order of nature, encourages us to praise him for the manifestation he has made of himself as a father to us in this frail and perishable life." (Calvin on Psalm 104)

The 202nd General Assembly advanced social policies to preserve the environment including global warming, water quality, protecting wildlife and wildlands, solid waste and hazardous waste management, and sustainable agriculture. Why? "So that all my know justice." (Restoring Creation for Ecology and Justice, 1990)

The 218th General Assembly advanced social policies to preserve God's creation in the face of global warming and the need to improve our nation's energy policy. "We stand with "the least of these"...and advocate for the poor and oppressed...who are often the victims of environmental injustice..." (Power to Change: U.S. Energy Policy and Global Warming, 2008)

The 221st General Assembly affirmed the Precautionary Principle as a method of "preventing irreversible ecological impacts" to the planet. The principle represents "a part of the basis for responsible moral, and scientifically-informed human flourishing, affirming the sacred in societal and creation care, and protecting the earth for future generations." (Overture 15-02, 2014)

The obstacle is real:

In the last decade, the decision to shift from historic annual Assemblies to biennial Assemblies was grounded in the logic of cost savings; greater time for governing bodies, agencies, and committees to act upon Assembly decisions; and, expanded space for discerning God's will within the life of the Presbyterian Church (U.S.A.) A consequence of the shift, however, has been a reduced opportunity to respond swiftly through General Assembly actions to the accelerating pace of world and national events. The shift has placed even greater weight on the reasoned and well deliberated policy positions of prior Assemblies. Yet, if an event or development presents itself unexpectedly, it may not have been addressed within previous policy guidance. This is true for environmental issues that are emerging as climate changes unfold. For Example, the COP 21 talks in Paris offers faith leaders an opportunity to join their voices on issues that affect those most impacted by those environmental changes. The PCUSA voice needs to be an immediate part of that. To wait for policy to come to the 223 General Assembly is to be left out of the very call Jesus gives to love our neighbors. To wait until 2018 to address critical fossil fuel extraction that drives climate change may mean irreversible damage for our planet and God's people.

The foundation is firm:

We are called by God to uphold the integrity of creation. Across the years, General Assemblies of the Presbyterian Church (U.S.A.) have repeatedly called for the protection of the environment. "Restoring Creation for Ecology and Justice (1990)," "Power to Change: U.S. Energy Policy and Global Warming (2008), and the 2014 General Assembly affirmation of the Precautionary Principle are contemporary, landmark positions of the Presbyterian Church (U.S.A.)

With the firm foundation of biblical charge and the established environmental policies of General Assemblies, leaders of the Presbyterian Church (U.S.A.) are called to faithfully address rising threats to air and water quality that may emerge from industrial processes including but not limited to fracking; crude oil shipment, storage, and export.

We are called as witnesses. With this empowerment, The Office of Public Witness and the Presbyterian Ministry at the United Nations can communicate with the President of the United States and Executive Departments; members of Congress and their staffs; state and local officials; and, corporate leaders when a new and arising threat to creation is presented.

2016 PCUSA Fossil Fuel Divestment Overture Recommendation

The Presbytery of the Northern Plains overtures the 222nd General Assembly (2016) to:

- 1. Express its profound concern about the destructive effects of climate change on all God's creation, including a disproportionate impact on those living in poverty and in the least developed countries; the elderly and children; and those least responsible for the emissions of greenhouse gases. The 222nd General Assembly (2016) thus recognizes the moral mandate for humanity to shift to a sustainable energy regime in a way that is both just and compassionate. This mandate compels us to action as a denomination to divest from the fossil fuel industry even as we reduce our use of fossil fuels and shrink our carbon footprint.
- 2. Call upon the Board of Pensions and the Presbyterian Church (USA) Foundation to:
 - a. Immediately stop any new direct investment in fossil fuel companies
 - b. Work to ensure that within three years, none of the Board's or the Foundation's directly held or commingled assets includes holdings of either equities or corporate bonds in the fossil fuel companies identified in the Carbon Underground 200 list¹ by:
 - i. Working with current and prospective asset managers to develop and implement institutional fossil free investment options
 - ii. Establishing within one year fossil free investment options for fund participants
 - iii. Actively seeking out and investing in renewable and energy efficiency related securities
 - iv. Notwithstanding the above provisions, retaining or acquiring minimal sufficient investment in fossil fuel companies to participate in shareholder engagement activities
 - Notwithstanding the above provisions, taking no action inconsistent with fiduciary duty or principles of sound investment, including the real and substantial risk of stranded carbon assets
 - c. Incorporate into public financial reports regular updates detailing progress made towards these ends
- 3. Call upon the Stated Clerk of the PC(USA) to inform affected fossil fuel companies and the larger public of the passage and implementation of this resolution
- 4. Call upon, and provide instructional materials to assist all levels of the denomination (presbyteries, congregations, and individual members) in taking action to slow climate change, including: divestment of fossil fuel holdings; shareholder activism; investments in renewable energy; advocacy at local, state, and federal levels for policies to reduce greenhouse gas emissions; and local efforts to reduce carbon footprint consistent with the 2006 call² for denominational carbon neutrality, and the 2008 "Power to Change" recommendations.³

2016 PCUSA Fossil Fuel Divestment Overture Rationale⁴

In 1981, our church made clear through the document "The Power to Speak Truth to Power" the importance of transitioning away from a fossil fuel-based economy.

In 2008, our church made clear through the document "The Power to Change" that the catastrophic effects of climate change make this transition essential to the preservation of human life and God's good creation.

Our church has voiced support for legislation encouraging a fossil-free economy, but has no power to enact it. Our church has voiced support for taxes on carbon emissions, but has no power to levy them. Our church has asked us and our institutions to cut carbon emissions, and we have, but that is not enough to shift the course of the economy or the climate.

Our church also invests hundreds of millions of dollars in fossil fuel companies.

We, as Christians, have the privilege, responsibility and obligation to speak with moral authority on issues of great importance. This is such an issue.

As we work to mitigate the climate crisis, we must shed the burden of our investments in climate destruction. This act will speak more loudly and more clearly than any prophetic declaration.

This overture asks us to sever our financial ties to the fossil fuel industry as a means of social witness in the world. When we join the worldwide divestment movement, our voice will amplify the voices of others as we collectively say that it is wrong to profit by harming creation.

Biblical and Theological Rationale

This action is rooted in the foundational theological and biblical principles of our Presbyterian identity. In Genesis 1 and 2, God gave humanity our vocation as stewards of creation. In Matthew 25: 31-46 Jesus calls on us to care for our fellow human beings, including "the least of these."

Human caused climate change is destroying creation and creating a reality in which more and more people are hungry, thirsty, homeless and devastated by diseases, wars and civil unrest. This destruction and the suffering it creates are directly at odds with our vocation as stewards and with what Jesus commanded.

Climate Change Rationale

Most world governments – and the PCUSA – agree that we must hold global warming below a 2°C increase. To do so, we must stay within a carbon budget that was estimated in 2011 to be 565 gigatonnes (GT) of CO₂ equivalent. By the 222nd General Assembly, we will have less than 400 GT – around 10 years – left in our carbon budget. Meanwhile, fossil fuel companies have nearly 3,000 GT of CO₂ equivalent, or seven times our remaining budget, buried in fossil fuel reserves they intend to produce, and they spend hundreds of billions of dollars a year looking for more.

Denominational Rationale

Our denomination has long recognized a moral obligation to be faithful stewards of God's creation. We have acknowledged the realities of climate change and its impacts on the "least of these," and the need to take action. Previous General Assemblies (1981, 1990, 1996, 1998, 1999, 2003, 2006, 2008) have passed overtures, resolutions and reports warning us of the dangers of climate change and calling on us to reduce our energy consumption and transition away from fossil fuels. Divestment is the logical next step in accomplishing these ends.

Divestment Rationale

Divestment has a long history in our denomination as part of a strategy for pursuing mission objectives of the church in the world through socially responsible management of the church's assets.

The 196th General Assembly approved the report "Divestment Strategies: Principles and Criteria," noting that we can use our investments as a powerful tool to bring about social change. Divestment is contemplated only after persistent shareholder efforts to persuade a company to change have failed.

For more than two decades, our church's Committee on Mission Responsibility through Investment has engaged in shareholder action with fossil fuel companies. This approach can continue to provide a seat at the table to engage with the industry, but it has had no impact in addressing climate change.

The divestment principles and criteria also recognize the importance of working with the ecumenical community and acting in solidarity with other Christian bodies. To date, Episcopalians, Unitarians, Lutherans, Anglicans, Quakers, Methodists, the United Church of Christ, some Presbyterian congregations and the Churches of England and Scotland have committed to divestment.

Divestment also protects our financial interests. In the carbon-constrained world we are entering, the value of fossil fuel companies will decline. The International Energy Agency projects that carbon cuts great enough to stay below the 2°C threshold could leave nearly \$300 billion in fossil fuel investments stranded by 2035.

Jobs

Divestment is a prophetic witness that challenges the country to shift from fossil fuels to renewable energy and energy efficiency as quickly as possible. Job loss in the fossil fuel industry is a serious concern, especially to our brothers and sisters in states where the industry is prevalent. We as church can advocate for sustainable jobs and worker retraining. We as church can reinvest in sustainable industries. We as church must be sympathetic and caring about job losses in a single industry, but must also consider the greater good generated for wage earners, families and all of creation by moving away from fossil fuels. In the end, job losses will be more than offset by job creation in energy efficiency and renewable energy.

More Than Symbolism

When people act singly, their impacts may be more symbolic than effective, but when many act in unison, they can bring about massive social and economic changes. Consider the powerful social changes that divestment brought about with Apartheid, tobacco and Darfur.

Some say it is hypocritical to divest from fossil fuels while remaining dependent on them. It is equally hypocritical to gamble on the continued profitability of the fossil fuel industry while urging individuals to use less fossil fuel. Divestment and conservation go hand in hand, and both will work together to make renewable energy and energy efficiency more widely and economically available.

Summary

As Christians, we have the privilege and obligation to speak with moral authority on issues of great importance. The power and clarity of our prophetic voice must not be undermined by the hypocrisy of our investments in fossil fuel companies that amount to nearly two hundred million dollars.

Divestment declares that we are refusing to stay neutral in the fight against climate disruption. We stand united with our brothers and sisters around the world in refusing henceforth to make money from an industry that is harming all of God's creation.

"Can we hear the grave warnings in reports like this one [Power to Change] from Christians who have carefully studied these matters? And then can we act as stewards of God's earth, witnessing to Christ in the re-direction of our lives toward a more sustainable future? I pray that we can, and that our church's good work can help in this great change."

On advocacy against factory farming

Seeking justice for our neighbor, and in service to God's creation, The Presbytery of the Northern Plains respectfully overtures the 222st General Assembly (2016) of the Presbyterian Church (U.S.A.) to:

- 1. Direct the Presbyterian Office of Public Witness to advocate wherever possible in favor of alternatives to CAFOs (Concentrated Animal Feeding Operations) or IFAPS (Industrial Food Animal Production Sites), commonly known as factory farms, and to advocate against measures that support industrialized animal farming.
- 2. Direct the Presbyterian Office of Public Witness to advocate in support of farm and processing plant workers, "fence line" communities surrounding factory farms, racial ethnic farmers, and family farmers and ranchers.
- 3. Reaffirm the 1990 proclamation "Restoring Creation for Ecology and Justice" which asserts that humanity and nature are so inextricably bound that the suffering of one affects the other. The Presbyterian Church (U.S.A.) has a history of affirming that protection of the environment is an essential part of the Christian faith.
- 4. Encourage all levels of the denomination (presbyteries, congregations, and individual members) to purchase only meat that carries the minimal certification of "Certified Humane Raised & Handled."

Rationale

A. THE CONFESSION OF 1967: RECONCILIATION IN SOCIETY

"In each time and place, there are particular problems and crises through which God calls the church to act. The church, guided by the Spirit, humbled by its own complicity and instructed by all attainable knowledge, seeks to discern the will of God and learn how to obey in these concrete situations (Confession of 1967, 9.43)."

These current particular challenges:

- a safe and sustainable food supply in the United States,
- environmental degradation from our current ways of industrialized farming,
- risks to humans from what is fed to food animals, and
- global hunger from an imbalance in what we in the United States take from the earth and what we give back point us toward changes that are necessary in our food production. One of those necessary changes is to end factory farming of animals and the farming monoculture of corn and soy, which is done in large part to support factory farming of food animals.
- B. We can talk about the web of creation that binds us to all living things and to the earth through lifting up common biblical themes from our Judeo-Christian tradition. And in so doing, we can speak of sin, as Barbara Brown Taylor has, as "wrecked relationships" within that web. During the past half-century, as industrialized farming of food animals has developed, we have broken relationships with the earth, with other living things, with other human beings, and with food itself as a gift from God. (Taylor, Speaking of Sin, cited in "Just Eating?", p. 43)

Ps 145:15-16: The eyes of all look to you,
and you give them their food in due season.
You open your hand,
satisfying the desire of every living thing.

Genesis 9:16-17: "When the bow is in the clouds, I will see it and remember the everlasting covenant between God and every living creature of all flesh that is on the earth." God said to Noah, "This is the sign of the covenant that I have established between me and all flesh that is on the earth."

Matthew 22:37-40: [Jesus] said to him, "You shall love the Lord your God with all your heart, and with all your soul, and with all your mind.' This is the greatest and first commandment. And a second is like it: 'You shall love your neighbor as yourself.' On these two commandments hang all the law and the prophets."

Romans 8:21-22: ...that the creation itself will be set free from its bondage to decay and will obtain the freedom of the glory of the children of God. We know that the whole creation has been groaning in labor pains until now...

"What role can the church play in shaping the future? We are called to participate in and influence this agricultural revolution by breathing fresh life into the values of sustainability, stewardship, compassion, and community." The issues are so complex, however, that the directive of this overture is very broad. But as Keeve Nachman, PhD, of Johns Hopkins University has observed, we can identify certain populations that pay the price for the inexpensive animal protein in our food markets. Those vulnerable populations bear the brunt of many risks that are hard to measure because large corporations generally own impenetrable vertically integrated "farms". Vertical integration means that one entity owns the animals, controls the inputs (food, chemicals, antibiotics, hormones), and owns the processing plants. Therefore that entity controls access to the market as well. These CAFO/IFAPS combinations are becoming legally impenetrable due to what are known as "Ag-Gag" laws. These laws make it a crime for undercover investigators or whistle-blowers to expose illegal activity on the grounds of one of these corporate properties. (In other words, it becomes illegal to expose illegal activity, and in some cases, not just a misdemeanor.)

So, once we have identified the vulnerable populations, it will then be important to consider what areas of concern might offer potential for impacting the people, the land, and the humane treatment of the food animals. ("We Are What We Eat," PCUSA Report, 2002, pp. 13, 17; Nachman lectures, Johns Hopkins "Introduction to U.S. Food Systems")

First, are the workers in U.S. IFAPS. It may come as a shock to us that they are not under the oversight of OSHA. (Nachman; PCUSA, 15) There is, in this industry, a high rate of injury among workers. But the lack of OSHA regulations is particularly disturbing because their work involves many chemicals in both the feed for and waste from the animals, in the air of both CAFOs and slaughterhouses, and in fertilizers that crop workers are in contact with. Perhaps the most concerning and best documented chemical is inorganic arsenic. Often there is no personal protective equipment available nor any decontamination facility for use after a shift. In addition to this lack of oversight, many workers are immigrants, both documented and undocumented, which adds another layer of vulnerability --- language, insurance, legality, education, and economics.

The Church has an additional concern over that of the secular world. Government agencies should indeed be concerned with physical safety, economic and racial ethnic concerns, and so forth. But for those who work in the violent and desensitizing atmosphere of the slaughterhouse or in the mind-numbing and soul-stealing CAFO environment where the expectation is solely to produce animals as commodities in as low-cost manner as possible, the Church needs to minister to the emotional and spiritual wounding of the workers. We

have nurtured them to be compassionate; and as a society, we have surrounded them with media images of heroes and rescuers. And then we have abandoned them.

Isaiah 1:15: When you stretch out your hands, I will hide my eyes from you; even though you make many prayers, I will not listen; your hands are full of blood.

"People must have renounced, it seems to me, all natural intelligence to dare to advance that animals are but animated machines.... It appears to me, besides, that [such people] can never have observed with attention the character of animals, not to have distinguished among them the different voices of need, of suffering, of joy, of pain, of love, of anger, and of all their affections. It would be very strange that they should express so well what they could not feel." ~Voltaire

The second population is the "Fence Line" and surrounding communities, mostly concentrated in the Southeast United States, mostly rural, and generally in depressed economic areas. Negative consequences of living in proximity to an IFAPS or CAFO fall into three general areas:

- 1. Respiratory and mental health issues. (asthma, allergies, depression, etc.)
- 2. Odors (compromised quality of life)
- 3. Economic effects (property damage and diminished property values) (Nachman)

We who are committed to those living in poverty, to those without access to power and privilege, to those living in oppressive circumstances, need to take note of this population whose lives are disrupted, and whose land and water are polluted by vast quantities of animal waste, containing chemicals, antibiotics, viruses, bacteria, heavy metals, and hormonal substances.

The water sources for about 43% of the U.S. have had pathogen contamination associated with manure. Twenty-nine states have identified other pollution problems from CAFOs. Groundwater constitutes 40% of public water supplies, but a full 97% of rural water supplies! (http://www.pewenvironment.org/news-room/datavisualizations/infographic-cleaning-up-cafo-permit-rules-85899431053, and Nachman) Although focusing only on poultry, the Pew Charitable Trust describes it best, in a summary of their 2011 report, "Big Chicken: Pollution and Industrial Poultry Production in America." The report compiles and analyzes 50 years of federal and state government data to describe a business that has been remade by industrialization:

"The broiler industry has changed drastically over the last 50 years and now produces more than 8 billion birds—an increase of more than 1400%—despite the loss of 98% of broiler operations. The typical broiler chicken comes from a facility that produces more than 605,000 birds a year. The majority of these massive operations—millions of chickens and the billions of pounds of waste they produce—are concentrated in a handful of states that comprise the American Broiler Belt." (http://www.pewenvironment.org/news-room/video-library/the-rise-of-industrial-scale-chickenproduction-85899362476)

"The shift from the traditional diversified family farm to a more industrialized system of raising animals has contributed to the transformation of food production and rural communities in the United States. Family farms have been replaced by an industry that dictates how the animals will be raised but leaves farmers liable for waste disposal and the financial burdens associated with housing thousands of hogs or tens of thousands of chickens. Marketing power is concentrated in the hands of a small number of large, vertically integrated companies that own, process and sell the animal products and bear none of the responsibility for environmental degradation.

"Across the country, water and air pollution from industrial livestock operations have compromised the health of communities and the surrounding environment. Huge volumes of manure are commonly stored in

open lagoons and applied to nearby land without treatment to control excess nutrients, pathogens and other contaminants.

"The largest industrial operations also use the most restrictive confinement methods, such as battery cages for laying hens and gestation crates for sows. These confinement types are not only among the least humane of farming practices but also contribute to the need for nontherapeutic application of antibiotics and the looming health crisis of antibiotic resistance." (http://www.pewenvironment.org/campaigns/reforming-industrial-animalagriculture/id/8589940398)

The third population is African American and other racial ethnic farmers. These "farmers and ranchers have suffered economic losses for a longer time than their white counterparts. . . . and if present land loss continues, there will be virtually no African American farmers by the end of the first decade of this century." Native American farmers have a similar situation, which may be more devastating, since farming is one of the primary occupations both on and off reservation lands. Asian Americans have a mixed story: Japanese Americans lost their farm ownership during World War II detentions, but Southeast Asian immigrants have found a niche in meat processing plants. Most interesting, however, is the Hispanic population, which has the largest number of new farmers. And yet, "the concerns of the lack of younger, beginning farmers may be shared by all groups." ("We Are What We Eat," 11) Small farms, it seems, are doomed unless something changes and changes soon.

C. Control of farm decisions are no longer predominantly in the hands of traditional farmers. Decisions are made in board rooms, far from the smell of manure, the feel of soil, the warmth of a cow's breath. What kinds of issues might the Presbyterian Office of Public Witness seek to influence in order to benefit these three vulnerable populations? This list is not in any particular order, and it is wide-ranging – but it is certainly not exhaustive:

Worker Protection Advocacy

EPA policies

Immigration Reform

OSHA Farm Policy

So-called "AG-GAG" legislation (making reports of criminal activity within IFAPS a criminal act)

International Trade Agreements

Clean Water and Clean Air Acts

There are Presbyterians everywhere – in board rooms, in sessions, in presbyteries, and in voting booths in communities across this nation. It is our responsibility to listen to what comes from our eyes and ears in Washington, and to stand by our brothers and sisters who are part of these vulnerable populations --- because we, too, are a vulnerable population. We are consumers of the products of the industrialized farms.
